The Regulations (inter alia) provide that annually the Intellectual Property Regulation Board shall make available to the public a copy of the entries in the Register of Patent Attorneys and in the Register of Trade Mark Attorneys as at the end of the preceding calendar year.

The Register of Trade Mark Attorneys is published in accordance with and to satisfy Regulation 3.6 of The Patent Attorney and Trade Mark Attorney Qualification and Registration Regulations 2009 and Regulation 26 of The IPReg Registered Bodies Regulations and is not to be used for any other purpose.

Regulation 20 of The IPReg Registered Bodies Regulations 2015 provides that:

“Subject to any legal restrictions on its ability to do so, IPReg may, in respect of a body or type of bodies, waive any provision in these regulations and any terms or conditions of Registration, and may revoke such a waiver at any time.”

The Intellectual Property Regulation Board hereby waives for the purpose of the publication of this Register of Trade Mark Attorneys pursuant to Regulation 26.1 of The IPReg Registered Bodies Regulations 2015 such information as is required under Regulation 26.2 paragraphs (a) to (l) (inclusive) to the extent that such information is omitted from this published register (but reserves the right to require provision of that information from any particular registered entity or entities or for any other purpose).

Rights to Conduct Litigation and Advocacy (with effect from 1st January 2013)

Pursuant to the provisions of Rule 3.1 of the Rights to Conduct Litigation and Rights of Audience and other Reserved Legal Activities Certification Rules 2012 this is to confirm that all Attorneys in Good Standing who were entered on this Register on or before 31st December 2012 (and who are not holders of a Patent Attorney Litigation Certificate or a Trade Mark Advocate certificate- see below) are automatically deemed to hold an Intellectual Property Litigation Certificate for 2012.

Attorneys in Good Standing who are Holders of a Patent Attorney Litigation Certificate or a Trade Mark Advocacy certificate on or before 31st December 2012 are automatically deemed to hold a Higher Courts Litigation Certificate for 2012 pursuant to Rule 3.2 of the above-mentioned Rules.

For these purposes "Attorneys in Good Standing" are those registered attorneys in respect of whose conduct there is no complaint outstanding and against whom there is no disciplinary record which in the view of the Patent Regulation Board or the Trademark Regulation Board affects their suitability to be a litigator or advocate.
